4 Health information / 健康信息
I, the undersigned official veterinarian certify that: / 我作为官方兽医在此证明:
4.1 Finland has been granted an officially free status in regard to Brucella abortus and Brucella melitensis by the EU legislation. Additionally, neither Brucella suis nor Brucella ovis have ever been detected in farm animals in Finland. Brucella canis has never been detected in fur animals in Finland. / 根据欧盟立法, 芬兰已被正式授予流产布鲁氏菌和马耳他布鲁氏菌免检资格。此外, 不管是猪布鲁氏菌还是羊布鲁氏菌都未曾在芬兰养殖动物中被检验出。犬布鲁氏菌也未曾在芬兰的毛皮动物中发现。
4.2 There has been no occurrence of rabies, brucellosis, tuberculosis on the farms of export foxes nor on the other fox farms in the neighbourhood during the three years prior to shipment. / 在发货前 3 年期间内, 不管是这些狐狸出口养殖场还是其附近其他的养殖场都未曾发现任何狂犬病、布鲁氏菌病和结核病的存在。
4.3 There has been no occurrence of parvovirus of fur animals nor dog distemper or pseudorabies on the farms of export foxes during the 12 months prior to shipment. / 在发货前 12 个月期间内, 在这些狐狸出口养殖场未曾发现任何毛皮动物细小病毒及犬瘟热或者假性狂犬病。

4.4 There has been no occurrence of infectious hepatitis and enzootic encephalomyelitis on the farms of export foxes and the farms situated within a 10 km radius of farms of origin during the past 3 years prior to shipment. / 在发货前 3 年期间内，在这些狐狸出口养殖场和位于这些原养殖场半径 10 公里范围内的养殖场里未曾发现传染性肝炎和流行性脑脊髓炎。

4.5 The foxes to be exported were born and have been raised on the farm, or they have been raised on the farm for at least 6 months. / 这些出口的狐狸出生于该养殖场并被养殖，或者至少在该养殖场养殖了 6 个月。

4.6 Prior to export, the foxes have been isolated for at least 30 days in an isolation premises approved by the Finnish Food Safety Authority (Evira), and have been subject to individual clinical examinations and to the following procedures: / 出口前，这些狐狸已在被由芬兰食品安全局所批准的隔离场所隔离了至少 30 天，并已接受个体临床检查和履行下列手续：

4.6.1 The foxes have been vaccinated against distemper (date of vaccination, type of vaccine, the effective period and the manufacturer has to be indicated below or in separate certificates). / 这些狐狸已被接种犬瘟热疫苗(接种疫苗的时间、种类、有效期和生产商必须在下面标注或者单独证明)。

4.6.2 Prior to export, all foxes have been vaccinated with vaccines against rabies and parvovirus infection approved by the Finnish Medicines Agency (the date of vaccination, type of vaccine, the effective period and the manufacturer has to be indicated below or in separate certificates). / 在出口前，所有的狐狸已被接种由芬兰药品管理局许可的狂犬病和细小病毒疫苗(接种疫苗的时间、种类、有效期和生产商必须在以下标注或者单独证明)。
