III Attestation

I, the undersigned Official Veterinarian, do hereby certify that:

- 1. the poultry eggs originate from Finland;
- 2. in Finland, there has been no outbreak during the last 12 months prior to the export to Korea of high pathogenicity form of avian influenza as defined by the WOAH code (HPAI);

OR

the Ministry of Agriculture, Food and Rural Affairs of Korea has recognized effective stamping out measures of Finland against HPAI and reduced this limit in accordance with the provisions of WOAH;

OF

in case of HPAI-outbreak in Finland, the edible eggs for export to Korea originate from HPAI-free zone which is updated and provided by the competent authority of Finland when necessary:

- a. the poultry used for producing edible eggs has been kept in HPAI-free zone and was not moved through the HPAI-restricted zones or was moved to or through HPAI-restricted zones under the conditions of using expressway and sealing of vehicle etc. determined by the competent authority of Finland;
- b. the farm producing the edible eggs comply with the EU animal disease control regulations and was under disease control measures administered by the competent authority of Finland; and
- c. the edible eggs originate from a flock that belongs to regular surveillance program for HPAI carried by the competent authority of Finland in accordance with EU legislation;
- 3. Finland is free of Newcastle disease in accordance with the WOAH code;

OR

within a 10 km radius around the poultry farms that produced the poultry eggs, there has been no outbreak of WOAH designated Newcastle disease for the past 60 days prior to the export to Korea. In the farm of origin, there have been no clinical, pathological or serological evidence of Newcastle disease for at least 60 days prior to export to Korea;

- 4. there has been no outbreak of salmonellosis posed by Salmonella enteritidis, Salmonella typhimurium and Salmonella thompson at the farms producing the poultry eggs for at least 90 days prior export to Korea. The farms participate in a Salmonella control program according to which samples are taken from laying flocks at least every 15 weeks for the detection of Salmonella. The first sampling takes place at the age of 24 weeks (+/- 2 weeks);
- 5. the edible egg-producing farm is participating in a poultry disease control programme operated by the competent authority of Finland;
- 6. the egg packing centre is approved and production farm is registered in accordance with the legislation of EU and Finland, periodically inspected and controlled by the competent authority of Finland and registered by Korea;
- 7. poultry eggs for export are derived from healthy poultry and are found suitable for human consumption on the basis of sanitary examinations conducted regularly by the competent authority of Finland;
- 8. the egg packing centre establishes and operates an in-house monitoring programme controlling residues in the poultry eggs as notified by the Korean government. The results of the monitoring programme comply with the Korean standards for residues. The egg packing centre maintains relevant monitoring records with other relevant documents generated in the course of implementation of such programme for more than 2 years; and
- 9. the poultry eggs are handled, packaged, stored and controlled in a sanitary manner until they are shipped for export to Korea. Transporting and handling of the eggs is conducted in a manner of avoiding re-contamination.
