V Attestation

- I, the undersigned Official Veterinarian, do hereby certify that:
- 1. the pigs originate from areas, which at the time of export are not under restrictions due to animal disease swine are susceptible to. They are found to be healthy, free from signs of any infectious and contagious disease including ectoparasites at the time of export and are fit to travel:
- 2. Finland is free from African swine fever in accordance with WOAH Terrestrial Animal Health Code;
- 3. Finland is recognized officially free from foot and mouth disease and classical swine fever (hog cholera) by WOAH and Aujeszky's disease in kept porcine animals in accordance with the EU regulation 2021/620, and vaccination against the disease is not carried out;
- 4. no cases of transmissible gastroenteritis (TGE) and brucellosis (suis biotype 2) have been reported in kept porcine animals in Finland for the past three years;
- 5. the animals originate from premises, in which
 - a. for the past 12 months prior to departure have been no clinical cases or other evidence of swine vesicular disease, tuberculosis, brucellosis, leptospirosis, swine influenza, porcine parvovirus infection, enterovirus encephalomyelitis (Teschen disease), TGE, atrophic rhinitis, toxoplasmosis, trichinosis and *Streptococcus suis* type 2 infection; and
 - b. for the past 2 years prior to departure have been no clinical cases of porcine reproductive and respiratory syndrome (PRRS), and vaccination against the disease is not carried out;
- 6. the animals have been kept isolated on the quarantine premises under official supervision with no contact to animals of lower health status, for a period of 30 days prior to departure;
- 7. the animals have, within the 30 day quarantine period prior to export, using test methods recommended by WOAH, been tested with negative results for the following diseases as indicated in part III of the certificate:
 - a. brucellosis
 - b. Aujeszky's disease
 - c. TGE
 - d. PRRS
 - e. Leptospirosis;
- 8. the animals have shortly prior to export been treated against internal and external parasites as indicated in part IV of the certificate;
- 9. the vehicles and containers used for transporting the animals have prior to loading been thoroughly cleaned and disinfected or heat treated in accordance with the relevant criteria laid down in the WOAH Terrestrial Animal Health Code;
- 10. the accommodation, provided for the animals during transport, must be designed to avoid any risk of injury and unnecessary suffering in accordance with the relevant criteria laid down in the WOAH Terrestrial Animal Health Code;
- 11. the ship or aircraft or other vehicles carrying the animals may only call at approved intermediate ports after leaving the country of origin. While in transit, the animals must not come in contact with other animals not having a similar health status. Unloading or movement of the animals may only take place under the approval and supervision of a veterinary authority of the transit country; and
- 12. no pigs or other animals not having a similar health status, nor animal feed or fodder is allowed to be taken on board the ship or aircraft after they leave the country of origin.
