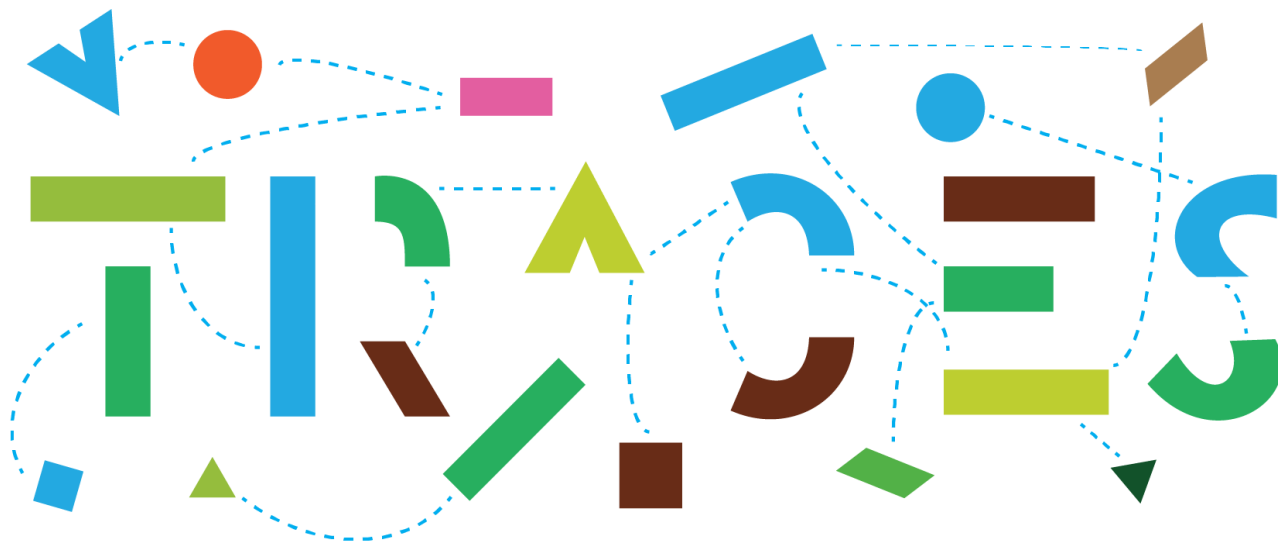

TRACES NT – Updated Veterinary Sections

April 2021

This guide contains all essential information concerning the new veterinary sections that were deployed in TRACES NT with version 5.7.0.

New Veterinary Sections in TRACES NT

Brussels, 15/04/2021

The aim of the present guide is to provide you with a detailed overview of the list of new veterinary sections implemented in TRACES NT, as well as with instructions on how to proceed with the exercise of creation of the approved and registered establishments and operators ("EU LMS") under these new veterinary sections.

On 21 April 2021 the new Animal Health Law (Regulation (EU) 2016/429), and the IMSOC Regulation amendment come into application. These legal acts foresee that the lists of EU LMS that need to be kept and maintained in TRACES by Member States' authorities will be extended to "Animal Health" and "Animal Welfare" establishments and operators in accordance with *doc SANTE/7148/2020 (adopted by Commission on 29 March 2021)*. The IMSOC Regulation amendment also indicates which of the lists of establishments and operators are to be made publicly available.

Accordingly, TRACES NT is to implement the revised listing requirements into new veterinary sections with a minimum of changes applied to existing sections, together with the visibility requirements from the new Establishment listings tab. In this regard, the updated list of veterinary sections is to be deployed with version 5.7.0 of TRACES NT (23/03/2021).

The new veterinary sections (as laid down in pages 3 & 4), will be deployed in parallel with the existing veterinary sections, which will remain available at least until the date of activation of the INTRA module in TRACES NT (October 2021), before being definitively deactivated with prior notice.

Starting from the date of deployment of the new veterinary sections in TRACES NT, you are kindly advised to register your new Animal Health and Animal Welfare approved and registered establishments and operators under the new sections.

In parallel, you are also advised to progressively adjust, where applicable, the sections and activities of existing establishments and operators under the old veterinary sections.

As regards the precise steps to follow for assigning a LMS activity and managing the EU LMS establishments and operators by authority users linked to the EU LMS National Contact Point entity, please refer to the updated INTRA Preparedness manual which was circulated to your services in the context of the INTRA Preparedness demos.
